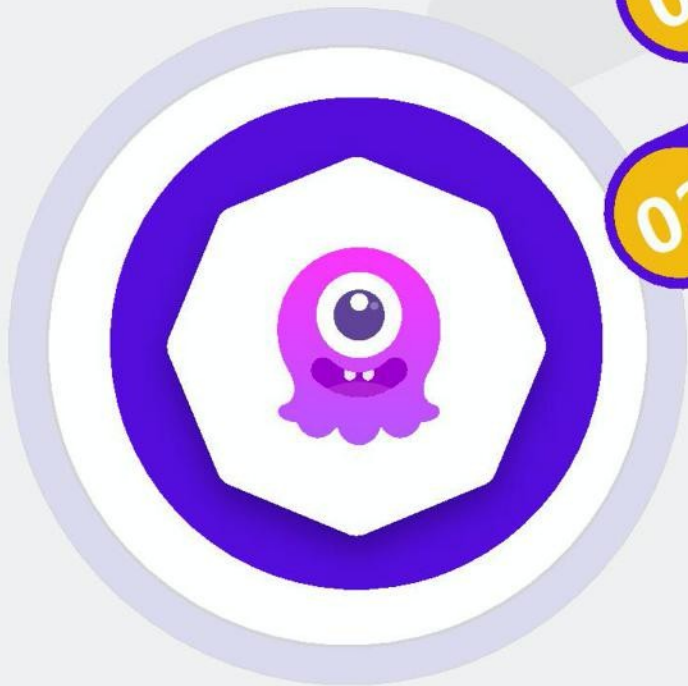

## Earning of Hostesses

01

### Earning of Hostesses

Hostesses earn The Beans by video calls and gifts. The price of their video calls range from 2,000 beans/min to 20,000 beans/min. A hostess can set any price in between this range which she thinks her callers can afford. Moreover, hostesses also can earn The Beans by receiving gifts, which have different values of The Beans.

### The Value of The Beans

10,000 Beans=1 USD



### The Commission Ratio of Agencies

The commission ratio of agencies is floating according to the total weekly revenue of an agency. This total weekly revenue is made up of two parts:

- 1 Part One**  
Total weekly earning of all his hostesses.
- 2 Part Two**  
Total weekly revenue of all his sub-agents.

## The Commission Ratio of Agencies

Different commission ratios are depending on the total weekly revenue of an agency.  
Check the chart below to know the details.

Class	A	B	C	D	E	F	G	H	I	G
<b>Total Weekly Earnings</b>	<USD 150	USD 150	USD 500	USD 1,500	USD 5,000	USD 15,000	USD 50,000	USD 150,000	USD 500,000	USD 1,500,000
<b>Commission Ratio</b>	0	5 %	10 %	15 %	20 %	22 %	24 %	26 %	28 %	30 %



### Calculation of Your Commission

Your total amount of commission is also made of two parts:

- 1 Part of Hostesses**  
corresponding commission ratio \* total weekly earning of all your hostesses
- 2 Part of Sub-agents**  
your total weekly revenue \* your corresponding commission ratio – one of your sub-agents' total weekly revenue \* his corresponding commission ratio  
(You may need to calculate this part more than once depending on how many sub-agents you have)

The sum of both parts is your commission and we pay the commission separately, so you should NOT deduct salaries of hostesses, or we may stop cooperating with you.



## Commission and Settlement

### Settlement and Payment

- 1** The time point of settlement is every Monday at 5:00 am (UTC+8).
- 2** We pay the salaries and commissions of yours to your Payoneer accounts every Thursday automatically, so you have to do nothing. Moreover, we practically deduct The Beans from hostesses' accounts after we have made the payment to your Payoneer accounts.

## Rules of Cash-out

### Apply to salary of hostesses and commission of agencies:

1. The cash-out amount must be  $\geq \$10$ . If the amount is  $< \$10$ , it will be accumulated and cashed out in the following settlement cycles.
2. The cash-out amount must be an integral multiple of 10, the remainder will be accumulated and cashed out in following settlement cycles.
3. If the callers request a refund from Google or Apple, we will deduct the corresponding amount from related hostesses.



## Rules for Hostesses

**Some serious violations would cause strict punishment such as banning the hostess from Chamet, confiscation of related agency' s commission.**



**1.** A hostess registers more than one account in Chamet.



**2.** A hostess switches agency to others, or an agency entices hostesses to own agency inside Chamet.



**3.** A hostess presents pornographic content during Public Live.(no limit during private video call)



**4.** A hostess is under 18 years old.

## Chamet Standards for Hostesses

Also, we use Chamet Standards to regulate some behaviors of hostesses. If they ignore the standards or warnings, we will remove her from the List of Popular, which will cause the fact that no callers can find them until they correct their unqualified behaviors.





### Standards of Live Posters

1

They should wear makeup or use a photo with beautification.

2

They should use a photo of themselves.

3

Their photos should be in high definition and with proper brightness.

4

Their photos should be with a tidy background.

5

They should use a half-length photo and dress decently.

6

They should record a voice self-introduction.



### Standards of Live Duration

1

Keep their faces in the box all the time.

2

They should be in a bright surrounding.

3

They should wear makeup and dress decently.

4

They should use earphones.

5

They should not lie down during live streaming.



## Chamet Standards

Last but not least, our AI system helps us to do these inspections and they are very sensitive, so please inform your hostesses of avoiding unqualified behaviors. Moreover, our AI system also can screen out hostesses who are not able to earn and stop distributing calls to them, so you should not recruit hostesses who are not good at this profession because they will be dismissed anyway.

# Registration as An Agency in Chamet

If you accept all the rules mentioned above, you can register as an agency in Chamet. After registration, we will provide a management system (<http://agent.ichamet.com>) to you, which helps you monitor your hostesses and sub-agents, check their salaries and your revenue, bind hostesses or sub-agents under your agency, and so on. Thus, you should master the management system because you will need to operate your team independently.
